Description	A global passport that entitles a CGI member to be granted most membership privileges from CGI Divisions that are not their home Division. Members remain on the register of their home Division.
Eligibility	Must be a paid-up member on the register of their home Division. Can be an Affiliated member, Associate or Fellow. Graduates are not eligible.
# of Divisions	A person can apply to as many Divisions as they chose.
Cost per application	A fee of 20% of the receiving Division's membership fee (for the same class of member). The fee is paid to the Division that is being applied to. There are no one-off registration fees.
Privileges	Access, as though a person is a Division Member, to all intellectual property, the membership rate for PD, training, networking events, any electronic journals and or eNews communication. When a Division charges their own members for any of the above, the passport holder pays the same amount.
Exclusions	A passport holder is not entitled to vote or participate in the governance framework of the Division they are applying to. A passport holder is not entitled to attend General Meetings of the Divisional Committee or any Service Companies.
Post-nominals	As all passport holders are members of The Chartered Governance Institute, the post-nominals of FCG, ACG or CG(Affiliated) are universal.
Verification	It is the responsibility of the passport holder to secure verification from their home Division when applying to access a new Division. A CGI global passport is valid for 1 year. The passport holder is responsible for verifying the validity of their home membership to the satisfaction of the receiving Division.
CPD points	The home Division agrees to grant CPD points for activity it considers eligible when undertaken from another Division.
